A remarkable commitment enabling patients to access essential cancer and hemodialysis care in Saint-Eustache.

Saint-Eustache, Thursday, November 6, 2025 — The Fondation Hôpital Saint-Eustache is pleased to announce it has received **the final payment of \$125,000** from the Fonds du Grand Mouvement Desjardins. This contribution completes the total \$500,000 pledge made at the opening of the Desjardins Health Center on December 9, 2019.

The Desjardins Health Center, **located at 14 Boulevard Industriel** and fully owned by the Fondation, includes the Alain Germain Cancer Center and the Outpatient Hemodialysis Center. These facilities provide essential care to the Lower Laurentians community. This funding will help maintain and enhance the quality of services for patients and their families.
